

# Bluebeard 3 Charter

## Cancellation Policy

### Cancellation or Modification

Private Charter are subject to change at the discretion of the Captain, and may occasionally be affected by variations in arrival or departure times, inclement weather, and mechanical or equipment difficulties. Bluebeard Charters reserves the right to change Excursion itineraries and departure times without notice. Excursions are subject to cancellation or modification depending on the number of guests participating.

### Cancellations & Refunds

The deposit you have placed to guarantee this excursion is **non refundable** for the exception of an inclement weather cancellation of the Tour by the Tour Operator, or due to your Ship not calling port

- If you cancel 15 days before tour date: 50% of the remainder balance will be charged **plus 15%** Administrative fee
- If you cancel 3 days before tour date or NO SHOW: 100% of the remainder balance **plus 15%** Administrative fee will be charged.

**Please note: we reserve the right to charge the credit card provided with your booking request to pay the above mentioned.**

Please note: A 15% administrative fee will be charged on your credit card for any chargeback of your excursion deposit when ruled in favor of our Company by your issuing Bank. If you dispute the deposit charge due to the charge not recognized a 15% administrative fee would be charged on your credit card. Your deposit will be noted on your credit card statement under ALDO N.V

All refunds we process over \$100 will be subject to 15% service charge per disputed charge.

**If you cancel due to sickness, health issue or death in family a doctor certificate for the cancelled tour must be presented and dated for the cancelled date in order to deviate from full balance charge.**

Please e-mail us back to this address including all text (the full body of the e-mail must be included, especially the date of when the reservation was received by you) from this reservation we had issued in order to notify us of a Port Cancellation by your Ship or an Inclement weather cancellation on behalf of Tour Operator. The reservation deposit will not be refunded unless a reply to this reservation is received confirming the refund request.

If you are not present at the appointed time and place of the start of the tour, your reservation is deemed cancelled. The Boat departs promptly from the dock at the time indicated on your reservation, **Should you require any last minute assistance prior to your arrival PLEASE CONTACT 1721-587-5935 immediately.**

### **PRIVATE CHARTER DEPOSITS**
